

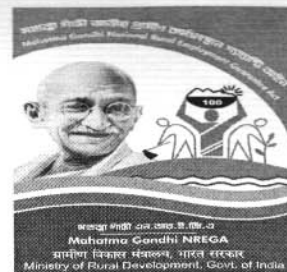

Sub Allotment of fund for raising nursery under MGNREGS.

The following funds under MGNREGS amounting to **Rs. 21,00,000.00** (Rupees- Twenty one lakh) only have been sub-allotted to the Programme Officers of Blocks of Jalpaiguri district to meet up the expenses of nursery raising schemes by SHGs from AAP- 2012-13 as detailed below under MGNREGS with immediate effect.

The scheme is to be implemented by the SHGs and regular monitoring and supervision is to be made by PO & BDO. **The remaining fund for raising nursery by SHG will be released after receiving the utilization certificate in due course.
