## Sub: - Important instruction for Social Audit under Mahatma Gandhi NREGA

The following sets of guidelines are hereby issued for the smooth implementation of MGNREG Audit of Schemes Rule, 2011. The guidelines are to be strictly followed by all concerned.

Regarding selection of Social Audit Volunteers, the following norms are to be followed:

- a. Team of five volunteers will visit a Gram Panchayat. They must not be resident of the concerned Gram Panchayat where they are engaged.
- b. In engaging Social Audit Volunteers the existing people who have over the time developed skill in job should normally be not disturbed.
- c. Whenever new Volunteers are to be engaged, the selection should be made from the unemployed youths preferably having minimum qualification of Class X pass.
- d. Volunteers must no be Block / GP employee, GP/PS/ZP Member or office bearer.
- e. In a team of 5, at least 3 should be women volunteers.
- f. The Block Development Officers will invite applications from the willing persons and finalize the list. A committee comprising BDO, Jt. BDO and the Block Social Audit Coordinator will complete the selection process. This committee will also decide on further details regarding selection of the volunteers.
