



Sub: - Rozgar Diwas under Mahatma Gandhi NREGA

This is to appreciate the way Rozgar Diwas was observed in all the Gram Panchayats during November, 2013 throughout the district. The programme was successful in capturing demand for work under Mahatma Gandhi NREGA.

A day — wise calendar may be prepared to observe Rozgar Diwas at least once on a monthly basis at the Gram Sansad level in each of the Gram Panchayat, for the remaining months in the financial year, and may be circulated to the concerned Gram Panchayats for compliance and be shared with the undersigned. All the Gram Panchayats may be instructed to display the same through wall — writing at Gram Panchayat premises.

Objectives of Rozgar Diwas:

- i. To make the communities aware about Mahatma Gandhi NREGA employment opportunities.
- ii. To facilitate Job Card Registration process for inclusion of new families / adult members
- iii. To receive work applications from interested households and provide dated receipts on the spot.
- iv. To cater to the needs and requirements of the vulnerable groups of wage seekers.
- v. To record grievances and submit the same to appropriate authorities for redressal.
- vi. To respond to the needs of the job card holders and requirements for effective implementation of schemes.

The event will be presided over by the concerned Gram Panchayat Member. The Multiple Channels already identified for demand registration may facilitate the process of demand registration & issue of dated receipts during Rozgar Diwas. To further accelerate the entire process of demand registration & issue of dated receipts, the Gram Rozgar Sevak and the Addl. Gram Rozgar Sevak are hereby authorized to accept the demand application & issue dated receipts under Mahatma Gandhi NREGA.

A report on Rozgar Diwas as per the format circulated vide Memo No. 1427(13)/MGNREGS dated 31-10-2013 should be sent every month. Details about Rozgar Diwas preparation and the outcomes including photograph should be uploaded in the respective Block / Gram Panchayat facebook account for public information.
