

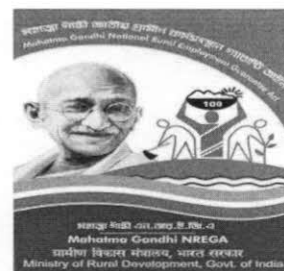

Sub-allotment of fund for IHHL under MGNREGS.

The following funds amounting to **Rs. 6,31,488.00 (Rupees – Six lakh thirty one thousand four hundred eighty eight)** only have been sub -allotted to the following Pradhan of Jalpaiguri District for the **Payment to Sanitary Marts Only @ Rs. 4,048.00 per unit for Completed & Ongoing schemes of IHHL of 2013-14 & 2014-15** under MGNREGS as per MGNREGA Guidelines.
