

Sub: Sub Allotment for Administrative Expenses under MGNREGS

As approved by the District Programme Coordinator, MGNREGS, W.B., Jalpaiguri the following funds under MGNREGS amounting to **Rs 40,770.00 (Rupees –Forty thousand seven hundred seventy)** only have been sub-allotted to the Programme Officers of Blocks of Jalpaiguri district as Administrative Expenses for Wages of Gardener @ 226.50 per day for the Month of November, 2013 to January, 2014. **The PO & BDO of the concerned Block is to give Wages to Gardener for 20 days in a month. The PO & BDO of the concerned Block may paid actual Travelling Allowance to the gardeners as per WB finance Rule out of Block contingency fund.**

The sub-allotted fund is to be made out of the available fund under MGNREGS. The P.O & B.D.O will submit requirement of fund time to time to this office along with Utilization Certificate. Further funds will be released only after fulfillment of the conditionality of 100% uploading of the MIS data as imposed by Govt. of India.

The PO & BDO(all) are hereby informed that further fund will not be released from this end if they have no available nursery works (at least 15 schemes per Gardener).
