## Sub: Sub Allotment for Administrative Expenses under MGNREGS

As approved by the District Programme Coordinator, MGNREGS, W.B., Jalpaiguri the following funds under MGNREGS amounting to Rs 40,770.00 (Rupees –Forty thousand seven hundred seventy) only have been sub-allotted to the Programme Officers of Blocks of Jalpaiguri district as Administrative Expenses for Wages of Gardener @ 226.50 per day for the Month of November, 2013 to January,2014. The PO & BDO of the concerned Block is to give Wages to Gardener for 20 days in a month.
