Further a sum of Rs. 4177.00 Lakh (Rupee-FOUR THOUSAND ONE HUNDRED SEVENTY SEVENonly) being unspent balance of the previous year 2012-13 was allowed to be brought forward for utilization during the current year 2013-14.

The miscellaneous receipt of the agency during the year 2013-14 was Rs. 31915.00 lakh (Rupee.THIRTY ONE THOUSAND NINE HUNDRED FIFTEEN.....only)

It is also Certified that out of the above mentioned total funds of Rs. 9881092.00 lakh (Rupees. ...NINTY EIGHT LAKHS EIGHTY ONE THOUSAND NINTY TWO..... only) a sum of Rs. 9880778.00 Lakh (Rupees. .NINTY EIGHT LAKHS EIGHTY THOUSAND SEVEN HUNDRED SEVENTY EIGHT ONLY..... only) has been utilized by the PIA during 2013-14 for the purpose for which it was sanctioned.


