Two Crore Forty Seven Lakh Seventy Three thousand Three only) a sum of <b>Rs. 247.726 Lakh</b> (Rupee Two crore Forty Seven lakh Seventy Two thousand Six hundred Eighty Nine only)  has been utilized by the PIA during 2013-14 for the purpose for which it was sanctioned.
