Further a sum of **Rs. 23770.50 Lakh** (Rupees .. Twenty Three Thousand Seven hundred Seventy only) being unspent balance of the previous year 2012-13 was allowed to be brought forward for utilization during the current year 2013-14.

The miscellaneous receipt of the agency during the year 2013-14 was **Rs18,839.00** (RupeeEighteen Thousand Eight Hundred Thirty Only)

It is also Certified that out of the above mentioned total funds of **Rs1,32,73,609.50** (Rupees. One Crore Thirty Two Lakhs Seventy Three thousand Six hundred nine only) a sum of Rs **13271345.00** (RupeesOne Crore Thirty two lakhs Seventy one thousand three hundred fourty five only) has been utilized by the PIA during 2013-14 for the purpose for which it was sanctioned.
