#### Sir/Madam.

In continuation of Memo. No. 6343-RD/NREGA/18M-11/08 dated 27.10.2011, I am to inform you that the State is facing an acute shortage of fund in respect of MGNREGS. As you are kindly aware, as per rules of the Ministry of Rural Development, Government of India, the 2<sup>nd</sup> installment of fund will be available only after the submission of utilization report of 60% of the previously allotted fund through MIS.

Till date, only 52% fund utilization has been reported through MIS, although the expenditure may be much more. You are requested to upload the expenditure report till 31st October, 2011 within 10th November, 2011 positively to facilitate this Department to assess the current situation and take steps to seek the 2nd installment from the Government of India.

This may be given top most priority.
