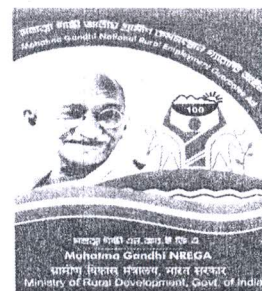

ORDER

With the support of MGNREGA, District Administration has succeeded to reopen 12 (twelve) TGs which were closed for last 6-8 years and this innovation has been appreciated by Central Government by awarding our District, the prestigious award "National Award for Excellence in MGNREGA Administration" for outstanding performances in the year 2009-10 and for innovative application for livelihood security in reopened TGs through MGNREGA. Permissible works under MGNREGS are being extended to these TGs in order to provide employment to the Labourers having Job Cards during lean period and creation of assets in the Gardens for community developments.

There are huge lands lying unused in those reopened TGs, which can further be utilized through plantation of horticultural and non-horticultural species as a part of MGNREGA activities for economic upliftment as well as nourishment of poor labourers of the Gardens.

After careful consideration it has been decided that the Saplings of following quantities will be supplied to the New Managements of the reopened TGs for plantation in the Gardens following the MGNREGA guideline under overall supervision of concerned BDOs.
