

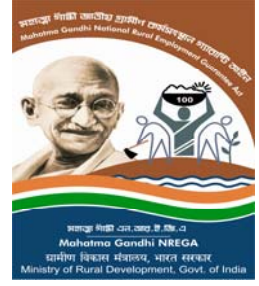

Subject: Custody of Bank and Post office pass books

Madam/ Sir,

We have been receiving reports from the fields that in several cases the bank and post office pass books of the job seekers are being operated by the supervisors / Gram Panchayat members / Pradhans of the GPs or some intermediaries. It should be ensured that no one directly or indirectly associated with the programme at the PIA level including the supervisors or the elected functionaries must be found with pass books of the Job seekers. If any such instance is detected the PO would initiate action under Section 25 of the Mahatma Gandhi NREG Act and send action taken report to the District for onward transmission to the State. Lapses in taking action on the part of the PO despite having specific information / evidence would be viewed as failure on the part of the PO in implementation of the provision of Section 25 of the Act the PO himself / herself would be liable to penal action by the DPC.

Copy of this order should be communicated to all the Pos and PIAs for compliance.

Subject: Uploading of photographs of worksites

Madam/ Sir,

Despite repeated requests the status of uploading of photographs of worksites in the NREGA portal is extremely low in the State. You are requested to take immediate measures to upload three photographs of each photograph (prior to commencement, during work and on completion of work) of all existing worksites by the end of March, 2013.

From April, 2013, onwards, no wage payment to the wage seekers would be made before uploading of pre-work photograph of worksite on the NREGA portal. No material bill would be cleared by the PIA till during work photograph is uploaded. Final payment of material bill would not be made till photograph of worksite on completion of work is uploaded in the website. This should be strictly followed by all the PIAs. Kindly circulate this order to all the Pos and PIAs of your district.
