Sub: Engagement of VLEs under MG NREGA

Sir,

During deputation from VLEs, a few issues were raised which should be addressed properly better performance of VLEs, who are to be paid for the work on piece rate basis at G.P. Level under MG NREGS, the following measures should be taken as below:

- i) A list of VLEs showing the GP assigned to each of them should be there and available with the concerned authority at the block and G.P. level.
- ii) The VLEs should not be changed frequently and arbitrarily without proper reason.
- iii) Trained VLEs should not be changed if their services are found satisfactory. The training imparted to the VLEs becomes in fructuous if they are disengaged too often.
- iv) Payment should be made to the VLEs every month regularly.
- v) Actual cost of travel, if required, should be reimbursed to the VLEs.

You are, therefore, requested to issue an instruction to the all concerned to follow the above measures in respect of VLEs engaged at GP. Level.
