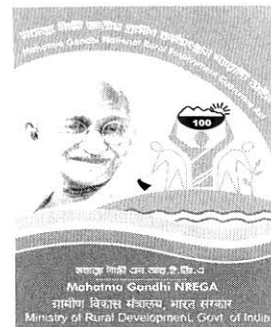



In continuation to this office previous letter no 3586(21)-RD/NREGA/18M-02/07 dt. 22.06.11, this to inform you that we have uploaded only 478603 nos. of family as BPL under MGNREGA, i.e. only 4.4% of total registered Household and 30931 nos. of RSBY family under MGNREGA. MoRD, Govt is pressing very hard to upload 100% BPL and RSBY Household status under MGNREGA. To achieve the requirement we have to complete the uploading of BPL Status of the Household under MGNREGA at an earliest. I am directed to request you give necessary instructions to update required registration information immediately so that actual scenario of RSBY and BPL status of Household under MGNREGA is reflected within next 15 days.

I am also directed to request you to update all other information of Registration listed in the aforesaid letter sent from this department.

Subject: Updation of BPL & 'Rashtriya Swasthya Bima Yojana' (RSBY) status of MGNREGA households in MIS (NREGASoft).

Sir/Madam,

As you aware that insecurity relating to absence of health cover, heavy expenditure on medical care & hospitalization and recourse to inadequate & incompetent treatment is not only a social and psychological burden borne by MGNREGA workers but there are significant economic costs resulting from loss of earning and progressive deterioration of health. Thus, with a view to providing health insurance cover to MGNREGA households in the unorganised sector and their families, the Central Government had announced to include MGNREGA households under the RSBY. All MGNREGA household who have completed at least 15 days of employment in preceding year are covered under RSBY irrespective of whether they are BPL or APL.

2. In order to track the above information following provisions has been made in the MIS while entering a new Job card or updating the information in a Job card:

- BPL status of the Household and
- Status of the Household if covered under RSBY.

With respect to point 'a' & 'b' above the MIS reflects the status as "NO" by default. In case if the status is "YES" then option button has to be selected accordingly.

3. In the MIS around 12 Crore job cards have been uploaded. Out of this about 4 Crore Households completed 15 days of work during last year and about 2.2 crore households in the current year. State wise status has been enclosed. Priority should be given to these household who have completed at least 15 days of employment in preceding year.

You are requested to take necessary actions to update the BPL and RSBY status of household under MGNREGA within 15 days.
