NOTICE INVITING TENDER

Sealed tenders are hereby invited by the undersigned from the bonafied and experienced contractors, Registered Engineers Co-operative Societies and Labour Co-operatives having credential of similar type of work (as per list enclosed) and they have to abide by the following conditions :-

- (A) Application for "Tender Paper" should be submitted to this office during office house from 11.00 A.M. to 3.00 P.M. on 09/08/2011 along with S.Tax, PTCC and credential (in the form of Payment Certificate of a work of the Officer -in-Charge) to be submitted.
(B) In case of running work, work order and up-to-date Payment Certificate of the Officer-in-Charge must be produced.
(C) In case of registered Firm / Company the Partnership Deed and other relevant papers should be produced
(D) In case of Engineers Co-operative Societies and Labour Co-operative Societies "Audit Report" of the last financial year will have to be submitted. The tender forms are to be received by the Chairman or Secretaries or any members of the society having proper power of attorney.

The above documents should be submitted to the undersigned at the time of application in original and photocopy thereof, the original documents will be returned after scrutiny and the photocopy may be preserved by the undersigned.

- Tender papers will be issued to the qualified contractors/applicants on 16/08/2011 from 11.00 A.M. to 3.00 P.M. from the office of the undersigned. The undersigned is not bound to issue tender papers to all applicants. The undersigned may issue tender paper for any work (as detailed in the enclosed list of work) to the contractor. Submission of application will not confirm the applicant to get Tender Paper. Decision of the undersigned regarding issue of Tender Paper is final.

Tender Paper will consist of Tender Form, Terms & Conditions, Schedule of Rates of work/ materials etc. All the papers should must be signed by the tenderer before submitting the same.

- Tender Paper will have to send by registered post or by hand and it should reach the office of the undersigned within 3.00 P.M. on 19/08/2011. Tender papers received after the scheduled time & date will not be entertained. It will be opened on the same day in the office chamber of the undersigned at 3.30 P.M. in presence of the intending tenderers who like to be present. This office will not be responsible for the loss of tender form or for the delay in postal transit.

- The earnest money mentioned against the name of work will have to be deposited in the form of DCR/Pledged NSC/nationalised Bank Draft in favour of the undersigned along with the tender paper otherwise the tender paper will automatically be treated as cancelled.

- The rate should be quoted in percentage both in figure as well as in words. Any illegible handwriting or overwriting in the tender paper will be liable to cancel the same. Incomplete and unsigned tender paper will be rejected summarily.

- Before submission of tender the contractor must visit the site of work to judge and to review the entire position of the worksite.

- The sealed envelop containing the Tender Paper should be superscribed on its top the Serial No. of work & NIT No. The envelop would naturally be addressed to the undersigned but mentioning also the name & address of the tenderer.

- Acceptance of the lowest tender is not obligatory and the undersigned reserves the right to accept or reject any or all the tender papers without assigning any reason whatsoever and also to split up the tendered work to more than one contractor in the interest of scheme execution.

- The successful contractor shall have to execute a formal agreement on a non-judicial stamp worth Rs.10 Only before starting the work.

- The successful contractor have to complete the work within the time specified for completion of work.

- This notice shall form part of terms & conditions of tender and the participants shall be bound to abide by them. The undersigned may apply some more conditions at any time even after execution of formal agreement for the interest of work.
