One hundred thirty two crore fourteen lakh fifty three thousand only) was received by the District Jalpaiguri as Grants-in-Aid during 2014-15 from the Govt, of India vide Ministry of Rural Development Letter No.& dated given on the margin and Rs. 1827.02 Lakh (Rupees. Eighteen crore twenty seven lakh two thousand only) from the State Government vide Letter No.& Dated given on the margin and Fund received through e-FMS Rs. 2670.95 Lakh (Rupees. Twenty six crore seventy lakh ninety five thousand only) .Further a sum of Rs. 1250.45 Lakh (Rupees. Twelve crore fifty lakh forty five thousand only) being unspent balance of the previous year 2013-14 was allowed to be brought forward for utilization during the current year 2014-15. The miscellaneous receipt of the agency during the year 2014-15 was Rs. 100.88 lakh.

It is also certified that out of the above mentioned total funds of Rs. 19063.83 lakh (Rupees. One hundred ninety crore sixty three lakh eighty three thousand only) a sum of Rs. 11640.85 lakh (Rupees. One hundred sixteen crore forty lakh eighty five thousand only) has been utilized by the District during 2014-15 for the purpose for which it was sanctioned and Rs. 7219.76 lakh (Rupees.
