- Henceforth, Shri Shymalendu Pal will act as Ombudsman of Purba Medinipur only.
- Henceforth, Shri Santi Priyo Das will act as Ombudsman of Bardhaman only.
- Henceforth, Shri Sailesh Kr. Talukdar will act as Ombudsman of Malda & Dakshin Dinajpur only.
- The office of the MGNREGS OMBUDSMAN shall be located at the District Headquarters and preferably, near the District MGNREGS Cell. Technical & administrative support to the OMBUDSMAN should be provided by the District Authority.
- An OMBUDSMAN shall be allowed a compensation of Rs. 500/- per sitting. Official accommodation should be provided by the district authority to the OMBUDSMAN during his stay at the district. An OMBUDSMAN will get AC- 3 Tier train fare (to & fro) for attending his duties. Official vehicle or TA/DA will be admissible to an OMBUDSMAN for conducting spot verification.
- All aspects of an OMBUDSMAN including Powers, duties etc. will be governed & regulated by the instructions for NREGS Ombudsman (and subsequent clarifications thereof) which have been formulated under Section 27 of MGNREG Act by MoRD. Those instructions are available at <http://nrega.nic.in/circular/Ombudsman.html>.
- To start with, every OMBUDSMAN should give atleast 2 sittings in every month in each district assigned to them.
- All expenses related to an OMBUDSMAN should be borne by the concerned district authority out of the 6% contingency of MGNREGS.
- The persons who have been selected to act as OMBUDSMAN are requested to report to the concerned district authorities with a copy to this Department at the earliest.
